**RULES and REGULATIONS**

1. **Eligibility:** This competition is open to all dancers of a competitive caliber. This is strictly a **TRADITIONAL** Mexican folk-dance competition.
2. **Entry Forms & Fees:** Entry forms may be duplicated as needed. Be sure to keep a copy for your records. Make sure that all entry information is accurate. Mail all entry forms, fees, and release forms in one packet.

Please send one check, made payable to ALCORTA'S FOLKLORICO DIAMANTE, for all fees. Entry fees are Non-Refundable. No Exceptions. Forms and fees must be postmarked by registration deadline.

**PAYMENT METHOD:**

- Company/School Check (no individual checks & a \$40 fee on all returned checks)
  - Cashier's Check
  - Money Order
3. **Categories & Time Limits:** There will be a 15 second "grace period" allowed for each routine. After a routine is 15 seconds over the time limit, 5 points will be deducted after the "grace period." After 30 seconds over the time limit, your entry will be disqualified. Time and classification limitations will be strictly enforced.

**SOLOS:**

Entries will be *baile regional*. All soloists will be separated by age category, not division; i.e. soloist ages 11-14 will compete against one another regardless if registered with a public school or private studio. **Only one solo per dancer.**

**DUETS:**

Entries will be *baile regional*. **Only male/female duets are eligible to compete.**

**ENSEMBLE, SMALL GROUP, LARGE GROUP:**

Entries may be danza autóctona or baile regional.

## CUADRO ARTISTICO

1. This is a separate section from the general competition.
2. All groups will compete head-to-head.
3. All groups should demonstrate a pre-professional or professional skill level.
4. Groups should be comprised of a minimum of 12 dancers (6 women & 6 men) and a maximum of 24 dancers (12 women & 12 men).
5. Group must only represent one Mexican state.
6. You may elect to present one general theme, or present different aspects of regional traditions.
7. The presentation of your Cuadro Artistico should include: Danza, Baile, and Cuadro Costumbrista (it is mandatory to include two of the three listed components; this is to say: danza y baile, danza y cuadro costumbrista, or cuadro costumbrista y baile). The celebrations of bautizo, cumpleaños, bodas, fiestas cívicas, campestres o patronales, las peregrinaciones, procesiones, mayordomías, etc., will be considered as a cuadro costumbrista.
8. The selection of danza, baile, or cuadro costumbrista is at performing group's discretion.

**Dance studios may apply their own additional administrative fees.**

### 4. Divisions:

- **High School**

- **High School** – The High School (Junior Varsity) division is targeted towards folklórico dance programs with students who have little to no competition experiences and are performing at beginner to moderate intermediate level.
- **High School Elite** – The High School Elite (Varsity) division is targeted towards folklórico dance programs with students who have significant competition experience and are performing at an intermediate-advanced level.
- *NOTE: A single high school may be entered in both divisions. For mixed level entries, the level of the routine is based on the level of the majority of the dancers. Judges can adjust the level of a routine at their discretion. Since no competition can possibly know how many hours a student dances, how many years they have danced, or the degree of competition experience, Directors are left to their own judgment when choosing a level for their entries.*

- **Private** (*Division based on average age of students in an individual entry.*)
  - Mini (3-6 years of age)
  - Pre-Junior (7-10 years of age)
  - Junior (11-14 years of age)
  - Senior (15-18 years of age)
  - Adult (19 years of age and above)
  
  - **ALL AGES ARE AS OF JANUARY 1.**
  - **Averaging of Ages:** To reach the average age of an entry, add all the ages together and divide by the number of dancers in the entry. When averaging ages always DROP THE DECIMAL POINT. For example, if a routine averages to an age of 14.7, you would drop the decimal; therefore, the routine would compete in the Junior Category (ages 11-14).

## 5. Awards:

- **Grand Champion:** This award will be given to the group showcasing the highest level of excellence during the entirety of the Competencia Folklórica De Tejas.
  - **Choreographer's Award:** The top three choreographers of the competition will receive a special recognition for *their original work*.
  - **Folklorista Award:** This award will be given to the group demonstrating a master knowledge of various regional Mexican dance styles during the competition.
  - **Judge's Choice Award:** This award is hand selected by the judges (does not take into account scores). It is awarded to a single entry of the entire competition that the judges feel embodies the essence of the traditions and customs of Mexico.
  - **Overall Soloist:** This award will be given to the highest scoring soloist of the entire competition.
  - **Overall Duet:** This award will be given to the highest scoring duet entry of the entire competition.
  - **Overall Division High Score:** The highest scoring ensemble, small group, or large group entry in each division will be awarded a "Best of the Best" trophy/recognition.
  - **High Score Awards:** The three highest scores in each division will be awarded high point trophies (1<sup>st</sup>-3<sup>rd</sup>).
7. **Participation:** All dancers must be enrolled with the participating school or organization. If an ineligible participant is found, the group will be disqualified. Backstage access is restricted to dancers, instructors, and directors. A performing group **MUST** always have an adult supervisor with them backstage. Groups will be responsible for any damages incurred while they are backstage.
8. **No group may duplicate an entry/dance in multiple categories or divisions.**
9. **The folklore of Mexico is rich and vast. With this, CFT will restrict the following regional dance styles to one entry per group: Jalisco Contemporáneo (Listones), Nuevo León-Centro y Linares, Sonas Jarochos de Veracruz, Calabaceados de Baja California, Huasteca Tamaulipeca. This is to encourage companies to research and investigate other regional dance styles. (This rule will not apply to solos/duets).**

- 10. Competing dancers may only compete for one studio/group, unless that dancer is part of both a private studio and public-school program.**
11. All CFT attendees authorize the use of their images in photos and video.
- 12. Music:** Have your music on your iPad or Laptop.
- 13. Stage Preparation Time:** There will be NO designated stage preparation time.
- 14. Props:** Hats, canes and other props maybe used as it pertains to the represented dances. Scenery, special lighting, knives, and fire are NOT allowed. Machetes must have “filo” removed. Use miniature lights in place of candles.
- 15. Schedule/Performance Times:** A competition schedule will be sent out no later than two weeks before the event. Read the schedule carefully. Competition times might run fast, so groups should arrive an hour prior to their scheduled times. Please be prepared.
- 16. Dressing Rooms:** Please use assigned dressing rooms and locations. **DO NOT USE PUBLIC AREAS AS CHANGING LOCATIONS.**
- 17. T-Shirts:** Order your *Competencia Folklorica De Tejas* commemorative t-shirt ahead of time at sale price as only a limited amount and sized will be available on-site. (Participant’s shirts are included with registration fee). Please return the t-shirt order form with your entry packet.
- 18. Video Recording:** There are no fees for video recording. Please be respectful of audiences when filming. DO NOT obstruct walkways. Tripods must be placed only in designated areas. Professional videos will NOT be sold.
- 19. Wavier & Release Forms:** The release form(s) must be submitted for contestants with the registration forms and fees. No dancers will be allowed to participate without a signed form on file. Please make additional copy of form if more room is needed.
- 20. Tickets:** Tickets for spectators will be on sales at the box office. Registered participants do not need tickets to enter.
- 21. Parking Fees:** Yes, the American Bank Center does charge for parking. Rates vary.
- 22. Travel:** Participating groups are responsible for their own travel and lodging arrangements. **All teams are expected to arrive to begin contest by Saturday morning at 8am.**
- 23. Hotel Block:** The Omni Corpus Christi Hotel will once again serve as our host hotel with a special room rate. We have a limited number of rooms available so please book ASAP.

# JUDGING CRITERIA

The judges and master workshop teachers for the *Competencia Folklórica De Tejas* are all distinguished “Investigadores y Maestros de la Danza Folklórica Mexicana”

No.	Aspectos	Descripción
1	<b>EJECUCIÓN</b>	Pisadas y pasos acordes al estilo de la región. Habilidad y destreza en la ejecución, así como limpieza en cada secuencia.
2	<b>PROYECCIÓN</b>	Postura y proyección corporal y facial de acuerdo al genero y carácter de la danza o baile.
3	<b>COREOGRAFÍA</b>	Diseños creativos en bailes y figuras dinámicas en danzas. Desplazamientos uniformes de los ejecutantes en tiempo y espacio.
4	<b>MÚSICA</b>	Utilización de conjuntos e instrumentos de acuerdo a la región que se presenta.
5	<b>RITMO</b>	Coordinación de la ejecución dancística con el ritmo de la música.
6	<b>VESTUARIO</b>	Utilización correcta de diseños, telas, y accesorios de la indumentaria a bailar en cada región.
7	<b>PORTACIÓN</b>	Portar correctamente cada una de las prendas y elementos (faldas, rebozos, sombreros, machetes, sonajas, paliacates, etc.) durante la ejecución.
8	<b>GRADO DE DIFICULTAD</b>	Grado de dificultad de acuerdo al estilo del estado que se representa y variedad de secuencias.
9	<b>AUTENTICIDAD</b>	Acercamiento a los cánones que se establecen al apego tradicional mexicano.
10	<b>IMPRESIÓN GENERAL</b>	Impresión de la composición dancística desde la entrada hasta la salida.

No.	Aspects	Description
1	<b>Execution</b>	Footwork is clean and in accordance with the regional dance style being presented.
2	<b>Projection</b>	Body expression, posture, and facial expressions are accurate representations of the culture or ethnic group being presented during the execution of the dance.
3	<b>Choreography</b>	Creative designs in regional dances and dynamic figures in indigenous danzas. Dancer’s movements are uniformed and timed/spaced accordingly.
4	<b>Music</b>	Music utilizes the appropriate instrumentation for the region being presented.
5	<b>Rhythm</b>	The dance selection is in coordination with the rhythm of the music.
6	<b>Costuming</b>	Correct utilization of designs, fabrics, and accessories in the attire of the region being presented.
7	<b>Usage of Costume/Props</b>	Propper use of costuming and props (skirts, rebozos, hats, machetes, sonajas, paliacates, etc.) during the execution of the presented dance.
8	<b>Difficulty</b>	Difficulty level and variety of sequences used during the execution of the presented dance.
9	<b>Authenticity</b>	Presented dance can be classified as an authentic representation of the region/ethnic group being presented.
10	<b>General Impression</b>	General impression of the presented dance from beginning to end.

Each group will receive a written critique from each judge for each performance. (Directors may pick these up after competition)
